Dear Artists, Craftspeople & Food Venders:

You are invited to submit your application for the ARTS AND CRAFTS FAIRE at the **3rd ANNUAL TEMECULA VALLEY INTERNATIONAL JAZZ FESTIVAL – ARTS & CRAFTS FAIRE, July 8, 2006.** The Festival is held on Main Street in Old Town Temecula.

The street will be closed from 6am until 10pm Saturday, July 8 for early set-up, with **very** easy unloading access, and nearby parking. **YOU MAY NOT TEAR DOWN BEFORE THE EVENT ENDS AT 10:00PM**

The fee for a booth space **10'x10'** is a flat **\$75. for Arts, \$175. for Food Venders** for the day – open 11a.m. to 9:30p.m., **no commission added – all vendors will be assigned a specific space.**

The Arts And Crafts Faire is only open to people who personally *hand craft* their items. Our past events have been a tremendous success and a great deal of fun for the artists and craftspeople participating. We have an excellent advertising committee and we guarantee extensive publicity and promotion. We do not, however, guarantee sales for our vendors; ultimately the buying public will decide what they wish to purchase.

REQUIREMENTS:

1. Complete the attached application. Be sure to fill out and sign 1) The insurance release & independent contractor statement, and 2) The hand made certification. Incomplete applications will not be processed.
2. Include at least 3 photos of your current work that you plan to display and sell at the show. Note that the photos must be representative of the items to be sold. Sale of items not represented in the photos or non hand-made items will result in closing your booth and forfeiting your entry fee.
3. Exhibitors **MUST** provide their own tables, stands, chairs, title cards and any other materials needed for their display. For your convenience and for an additional fee, we can provide the following equipment: 8 Foot Table - \$25.00; 10' X 10' "pop-up" - \$100.00. Please include your request and payment for the above equipment with your application – must be confirmed before July 1.
4. Include a \$75 entry fee made out to the Musicians Workshop, (**INCLUDE YOUR ADDITION FEES FOR RENTAL EQUIPMENT WITH THIS CHECK!**) **\$10.00 of this fee is a nonrefundable** processing fee if you cancel anytime prior to **June 1, 2006**. There will be NO refund after June 1, 2006.
5. Enclose a **stamped, self addressed envelope** for notification of acceptance and booth information.

Also note the following:

- A. Each exhibitor is responsible for monitoring their own booth.
- B. Each exhibitor must have a current seller's license and is responsible for their own money, taxes permits (Food Vendors **MUST** have a current Health permit) and licenses to operate in this area.
- C. The Arts And Crafts Faire occurs on Saturday. The Festival site is open at 7:00 a.m. for set up, and the site will be opened to the public at 11:00 a.m. Official Festival times will be from 11:00 a.m. until 10:00 p.m. on Saturday for the **MAIN STREET ART FAIRE**.
- D. Set up begins at 7:00 a.m., **NO** vehicles are allowed to remain on Faire grounds, (Main Street) – vehicles access before 10am and after 10pm only.
- E. For safety reasons, vehicles may **NOT** be brought onto the festival site.
- F. Space assignments will be given out when you arrive at the Festival.
